## NEW PRAGUE UTILITIES UTILITY RATES SCHEDULE

### RESIDENTIAL RATE

Electrical residential service is provided at single phase and at 120/240 volts.

Customer Charge.....	\$16.82 per month
Energy charge (kWh).....	@ \$0.1369 per kWh
Off Peak Summer kWh metered.....	@ \$0.0839 per kWh
Off Peak Winter kWh metered.....	@ \$0.0710 per kWh
Off Peak non-metered credit.....	\$5.00 per month
Car charging (10pm-8am) (kWh).....	@ \$0.0822 per kWh
Car charging (8am-10pm) (kWh).....	@ \$0.2507 per kWh

### COMMERCIAL RATE

Customer Charge.....	\$32.86 per month

### SMALL INDUSTRIAL RATE \*\*

Applicable to any customer with a demand in any month of the year in excess of 25 kilowatts of demand and less than 250 kilowatts of demand. Once you reach this demand you stay for 11 months.

Customer Charge.....	\$68.04 per month
Demand Charge.....	\$13.76 per kW per month
Energy Charge.....	@ \$.0753 per kWh

### INDUSTRIAL RATE \*\*

Applicable to any customer with a demand in any month of the year in excess of 250 kilowatts of demand and less than 2,000 kilowatts of demand. Once you reach this demand you stay for 11 months.

Customer Charge.....	\$120.00 per month
Demand Charge.....	\$14.14 per kW per month
Energy Charge.....	@ \$.0753 per kWh

### LARGE INDUSTRIAL RATE \*\*

Applicable to any customer with a demand in any month of the year that exceeds 2,000 kilowatts of demand. Once you reach this demand you stay for 11 months.

Customer Charge.....	\$140.00 per month
Demand Charge.....	\$17.20 per kW per month
Energy Charge.....	@ \$.0753 per kWh

\*\* Minimum billing demand charge shall be 75% of the maximum metered demand measured during the prior year for all above referenced industrial rates.

### SECURITY LIGHTING RENTAL

Security lighting is available under its own rate schedule for customers requesting it.

Security Lighting Rental.....	\$12.35 per month
Street Light – Residential LED.....	\$25.00 per month
Street Light – Commercial LED.....	\$35.00 per month

### COMMERCIAL/INDUSTRIAL DEPOSIT FEE

-Commercial electric deposit amounts will consist of two months estimated consumption based on connected load and demand. With minimum deposit of \$150.00.

-Industrial, Small Industrial and Large Industrial electric deposit amounts will consist of two months estimated consumption based on connected load and demand. With a minimum deposit of \$300.00.

### COMMERCIAL/INDUSTRIAL DEPOSIT FEE

Water/sewer deposit amounts will be based on meter size and two months estimated consumption. With a minimum deposit of \$100.00 for water and a minimum deposit of \$100.00 for sewer.

The New Prague Utilities Commission is governed by a five (5) person Commission that is appointed by the City Council. Each Commissioner serves a four (4) year term. The Commission convenes a business meeting on the last Monday of every month at 3:30 P.M., in the Utility office at the Power Plant.

# **NEW PRAGUE UTILITIES COMMISSION**

## **STATEMENT OF RATES AND POLICIES:**

The New Prague Utilities Commission was established for the purpose of providing electrical and water services to the residents of New Prague. The following information is to help serve you, the Utility customers, promptly and satisfactorily.

## **APPLICATION FOR SERVICE:**

Application for new, additional or temporary service must be made by the customer or his designated representative to the Utility business office. The customer will be required to provide information relating to the service request such as: type of service, location, date of service request is required and the name, address, and telephone number of customer. A \$200 fee is required for a residential temporary service.

## **DEPOSIT FEE:**

Each new customer is required to make a deposit when applying for utility services. Refusal or failure by a customer to satisfy the deposit requirements shall result in the delay of service until such time as the deposit has been made. This deposit bears interest at a rate established by the MN Statutes Section 325E.02. The deposit will be returned after a consecutive 24-month penalty free period or upon termination of the account. If an account holder's service is terminated voluntarily or otherwise, prior to the return of the deposit, the deposit and any accrued interest will be applied to any unpaid utility account balance, or any other debt owed to the New Prague Utilities Commission. Any remaining sums will be refunded to the account holder within 45 days. Such action shall not relieve the account holder from liability for any remaining debt owed to the New Prague Utilities Commission.

All deposits are non-transferable from one applicant to another and are only payable to the original applicant.

## **OWNERSHIP OF EQUIPMENT:**

Overhead service, metering equipment, in addition to the overhead service drop which is installed by the Utility is the property of the Utility. All residential underground electric services in addition to all metering and load control equipment installed by the Utility is the property of the Utility.

## **CUSTOMER CHARGE:**

There is a monthly customer charge billed to each customer receiving electric and/or water service. The amount of this monthly charge varies as to the type of service, which the customer receives. The monthly charge for each type of service is listed in the appropriate rate schedule.

## **RATE SCHEDULES CLASSIFICATIONS:**

Electric service is supplied to customers under various rate schedule classifications as determined by the type of service, the amount of electric power supplied and the purpose for which the electric is to be used.
