### RESOLUTION SUPPORTING SPECIAL LEGISLATION FOR ISSUANCE OF ON-SALE INTOXICATING LIQUOR LICENSE OF THE NEW PRAGUE GOLF CLUB

WHEREAS, New Prague Golf Club is owned by City of New Prague and is operated as an enterprise fund of the City of New Prague

WHEREAS, the intent of the enterprise is to be self sustaining.

WHEREAS, the New Prague Golf Club currently sells non intoxicating liquor, wine, and setups.

WHEREAS, the City of New Prague has limited authority under Minn Statute 340A.601 to establish municipal liquor operation.

WHEREAS, the Golf Board is an advisory body of the City of New Prague which is appointed by the New Prague City Council to advise in the every day operations of the Golf Course and Club House.

WHEREAS, the Golf Board has determined that the Club would better serve the market by the sale of intoxicating liquor.

WHEREAS, pursuant to due call and notification the New Prague City Council held a public hearing on Monday, March 6, 2006 to
