The certificate shall specifically provide that the certificate shall not be modified, cancelled or non-renewed. The insurance must provide that the City shall be notified by the insurance carrier of any changes to the policy or its term. All changes must be received and approved by the City Administrator at least thirty (30) days in advance of any proposed changes.
4. **Include license fee** \$100.00 for first vehicle, \$25.00 for each additional vehicle. Checks payable to the City of New Prague. Mail or drop off your payment and materials to the City of New Prague (address above).
